Jones-Onslow EMC customers who are installing an ENERGY STAR rated electric central AC, air-to-air heat pump, or a geothermal heat pump are eligible to take advantage of the Jones-Onslow ENERGY STAR rebate.

Eligible HVAC Systems	Rebate
High Efficiency Central AC (15 SEER)	\$35
High Efficiency Central AC (16 SEER or greater)	\$50
High Efficiency Heat Pump (16 SEER or greater)	\$250
Geothermal Heat Pump (19 EER or greater)	\$350

### System Requirements:

- When replacing an existing Central AC or Heat Pump unit, the old unit must not have a seasonal energy efficiency ratio (SEER) greater than 13.
- When replacing an existing geothermal unit, the old unit must not have an energy efficiency ratio (EER) greater than 17.

### Program Guidelines:

1. Applicant must be the customer of record for an active account.
2. Rebates are available for residential customers only.
3. Maximum of two rebates per dwelling.
4. Rebates are based on system efficiency (see chart above).
5. Additional requirements and/or conditions may apply.
6. Equipment must have been newly installed in the 90 days preceding the application for rebate.
7. Failure to provide required information may postpone the customer rebate.
8. JOEMC reserves the right to amend or discontinue this program without notice. All rebates are subject to approval and contingent upon fund availability.
9. Proof of purchase or copy of receipt required when turning in HVAC Rebate Application.
10. HVAC Rebate is only available for existing homes and replacement units -- new construction homes do not qualify for rebate.
11. Rebates are available for systems installed on or after January 1, 2017.
